6/21 Proposal by Councillor Penny Cushing that the new village map project receives a maximum budget of £2500.00 (ex. Vat) (including a map for each household plus a 20% additional number of maps for future new residents) to be approved by the council. Latest quotation distributed to all councillors prior to this meeting.

Cllr Penny Cushing confirmed that Rural Maps pricing for developing the map and producing the digital version and the larger maps for village notice boards remained the same at a cost of £1057.00 (exc. Vat).

She had now negotiated and much cheaper rate for the printing of the individual maps for each household using Treloars with the agreement of Rural Maps. The price for individual maps would therefore now be approximately £130.00 (exc. Vat). Therefore, this would be a substantial saving on the previous quote and the quality would be the same.

Cllr Cushing therefore stated that the cost would be under the maximum budget of £2500.00 (ex. Vat).
